## Privacy Policy

## Security of Information

## Information Privacy

Users who use our features agree and accept that authenticity of the data, and the consequences that may result from the posting of any personal information (either of themselves or any other person) are the sole responsibility of the user. Users further agree and accept that the terms of the Privacy Policy will be applicable to the use of all features, existing and new.

## Utilizing Information
